



BS PETeco: instruction for cleaning, daily maintenance, transport and storage

1. Transport conditions:

- Products made of PET should be protected against precipitation, moisture and direct moisture exposure to sunlight.

- The elements should be transported in a horizontal position and the edges of the load should be secured against damage, dirt and getting wet.

- The loading space intended for transport should not have any protruding, sharp elements that may damage the material. The environment adjacent to the load should be maintained in proper cleanliness.

2. <u>Storage conditions:</u>

- Products made of PET should be stored in a horizontal position and fully protected against contamination, damage or deformation.
- The room intended for storing the PET material should have a stable temperature. The humidity should not exceed 60%.
- The stored material should not be located close to heating devices.

3. <u>Cleaning tips:</u>

- Dirt such as dust, sand or crumbs resulting from everyday use should be cleaned regularly. They should be removed with light vacuuming. Always use a furniture brush in the direction of the gain. You shouldn't wait until visible signs of dirt will appear.
- In order for fibres to retain their original appearance as long as possible, the product should be wiped damp from time to time by chamois leather in the direction of the fibres. Do not use microfiber cloths!
- It is best to remove stains immediately after they occur. Spilled liquids should be wiped up immediately with an absorbent cloth in this case the liquid does nor penetrate the material.
- First, use distilled water for cleaning. Clean it as thoroughly as possible, always from the outside to the inside so as not to make the stain larger. If the water is not enough to clean, difficult stains can be removed by the liquid which
